Puppy Purchase Contract:

1. We do not offer any implied guarantee unless otherwise written herein. This contract is legally binding. This contract is signed in and governed by the laws of the State of Ohio. The parties agree that all actions arising in connection with this agreement will be litigated exclusively by the court system of Hardin County, Kenton, OH 43326.
2. Buyer will receive a chart with each puppy that shows current vaccinations and worming medications that have been given. It is the buyers responsibility to keep this record and maintain a vaccination schedule. We will not be liable for any adverse reactions/illnesses due to buyer's vet choosing to re-vaccinate your puppy. We give the puppies their shots on the dates listed on the vaccination record. Re-vaccinating a puppy can result in suppression of the immune system and subsequent illnesses.
3. Buyer must have the puppy examined for general health and a fecal test run by a licensed veterinarian within 72 hours from date of purchase/possession (excluding Sundays and holidays). If buyer does not have the puppy examined, this contract is void. If the puppy is diagnosed to be in life-threatening/poor health at that time, the puppy must be returned to the seller within 24 hours. After the puppy has been examined by the seller's veterinarian and the same diagnosis has been made, the buyer will receive a refund for the purchase price (as a check sent via certified mail) or a replacement puppy (as soon as one becomes available), at the buyer's choice. Seller is not liable for acute or preventative treatments for internal or external parasites, worms, fleas, coccidiosis, giardia. Seller is not liable for Hypoglycemia, (low blood sugar). This refund policy is for the purpose of illness related items only.
4. If the puppy is diagnosed to be in poor health due to a life threatening disease/viral infection (Parvo, Distemper) within 10 days from purchase, the puppy must be returned to the seller within 24 hours so that proper treatment may begin. The buyer will receive a like replacement puppy as soon as one becomes available. If the purchased puppy is diagnosed to have a congenital or hereditary defect which would greatly reduce quality or quantity of life, within one year from its date of birth, we will replace the puppy with a like one as soon as one becomes available. Buyer has 7 days from date of hereditary diagnosis to return the puppy to the seller. This may include heart, kidney, liver disease. If the puppy perishes within the guarantee periods, the seller may request that a gross necropsy be performed, at the buyers expense, to determine cause of death. Seller will reimburse up to \$100 towards the price of the necropsy if the cause of death is covered under this warranty. No puppy may be euthanized within the guarantee period without prior consent of seller. Doing so will void this contract.
5. Any returned puppy must have all signed and dated veterinary reports from date of purchase, including diagnosis and test results. The returned puppy is subject to inspection and testing by our licensed veterinarian before replacements will be issued. All fraudulent claims will be prosecuted. If at any time the buyer chooses to treat and retain ownership of a puppy diagnosed with a life threatening disease/viral infection or a congenital/hereditary defect, all warranties are void. No replacements will be offered from that point on. No refunds will be given. No vet bills will be paid or reimbursed, in part or in whole.
6. Buyer assumes all responsibilities associated with the purchase and care of a puppy. Seller will not be liable for accidents or puppies that are neglected, mistreated, malnourished or have not been seen by a veterinarian.
7. We strongly recommend that all puppies not intended for breeding purposes, be spayed/neutered. If you choose to breed, please do so responsibly. Please note that we sell all puppies for pets and companionship only. We do not guarantee the breeding potential or breeding quality of any puppy. If at anytime the original buyer can no longer keep and care for the puppy/dog, the buyer can surrender the dog to the seller and we will find the dog an appropriate adoptive home.
8. Seller is not liable for any veterinary bills. Seller will not reimburse in part or whole any vet costs, testing fees or medications. We are not liable for personal injury or property damage.
9. This contract is non-transferrable. All Sales are Final except as noted.
